The Board of Gage Roads Brewing Co Limited wishes to advise that 3,374,676 shares (raising \$269,974) have been issued today pursuant to Section 1.3 of the Entitlement Prospectus, bringing the total amount of shares issued under the Prospectus to 14,056,221 (\$1,124,498).

Pursuant to section 1.3 of the Prospectus the Company reserves the right to place the resulting shortfall of 37,168,656 shares (\$2,973,492) within 3 months after the closing date.

As previously communicated to the market, the funds raised will be applied to the Company's revised corporate and operational strategy. The strategy's objectives include the expansion of the Company's core range of products and distribution outlets over the next 24 months to meet growing consumer demand for craft brewed beverages and to take advantage of existing installed capacity.

In light of yesterday's announcement regarding the signing of a heads of agreement for a new distribution agreement and a \$2 million convertible loan note with VOK Beverages, the Board wishes to advise shareholders that they are still entitled to participate in the Entitlement Issue.
