EMPLOYEE SHARE PLAN ISSUE

Gage Roads Brewing Co Ltd (ASX: GRB) advises that in accordance with the Company's Executive and Employee Share Plan 31,000,000 shares have been issued today to 23 eligible employees.

The Company feels that incentive shares are effective consideration to eligible employees for their ongoing commitment and contribution to the Company.

This issue was made to the senior management team and other key employees (excluding Directors) and includes retention conditions to help secure these employees for the longer term benefit of the Company and all Shareholders.

The Employee Share Plan was approved at the Annual General Meeting of Shareholders held on 18 November 2014. The shares were issued at an issue price of \$0.063 each and corresponding limited recourse loan agreements have been executed in accordance with the terms of the Executive and Employee Share Plan.


