COMPLETION OF \$1.6 MILLION PLACEMENT

Gage Roads Brewing Co. Ltd (ASX: GRB) (“Gage Roads” or “the Company”) is pleased to announce that it has today completed a placement of 63,900,000 ordinary shares to institutional investors at \$0.025 per share to raise \$1,597,500 (“Placement”) as announced on 30 August 2016.

The Placement to five new institutional investors has been made in accordance with the Company’s 15% annual placement capacity and is to be applied towards working capital and covering the expenses of the placement.

Managing Director John Hoedemaker was pleased with the support from the institutional investors: “Demand for the institutional placement has been strong and sets a positive tone for the upcoming entitlement issue.

“We welcome the new institutional investors to our share register and look forward to their involvement as the Company delivers on its new five-year ‘Returning to Craft’ strategy.”


