SHARE ISSUE TO INSTITUTIONAL INVESTORS

Gage Roads Brewing Co Ltd (Company) (ASX Code: GRB) advises that 117,647,058 ordinary shares have been issued today to institutional investors at \$0.085 per share raising gross proceeds of \$10 million pursuant to the placement first announced by the Company on 8 June 2018 (**Placement**).

The Placement to institutional investors has been made without shareholder approval in reliance on the Company's 15% annual placement capacity.
