Through its contract brewing services division, Australian Quality Beverages, the Company also provides specialist contract brewing and packaging services to brand owners throughout Australia.

## **CLOSURE OF SHARE PURCHASE PLAN**

**Gage Roads Brewing Co Ltd (Company)** (ASX Code: GRB) wishes to advise that the Company's Shareholder Share Purchase Plan (**SPP**) is now closed. The SPP was announced to the market on 13 June 2018 and sought to raise \$2 million at \$0.085 per share (up to 23,529,412 shares) with funds raised under the Plan to be used by Gage Roads to partly fund the acquisition of Matso's Broome Brewing Pty Ltd.

The Company has received significant support from existing eligible shareholders, with applications totalling \$9.16 million being received by the closing date of the Offer, which was 5:00pm (WST) on 27 June 2018. The Company will be applying a prorata scale back in accordance with the terms and conditions of the SPP. The Company also received significant support for the \$10 million Institutional Placement, which required similar scale back.

## **UPDATE ON MATSO'S ACQUISITION**

The Company is pleased to announce that the acquisition of Matso's Broome Brewing Pty Ltd (as announced 8 June 2018) is now fully funded through the completion of the \$10 million Institutional Placement (as announced 21 June 2018), \$2 million Share Purchase Plan outlined above and remaining balance funded through existing cash facilities. The Company is in the process of finalising formal documentation and satisfying conditions precedent and expects to complete the transaction within the next 30 days.
