The Board of Gage Roads Brewing Co Limited wishes to advise that 4,800,000 shares (raising \$384,000) have been issued today pursuant to Section 1.3 of the Entitlement Prospectus.

The Directors are pleased to advise that they have also received firm commitments to subscribe for further shares from a number of existing shareholders (who were unable to participate in the entitlement offer within the required timeframe) totalling \$659,024 (8,237,802 shares).

The funds raised will be applied to the Company's revised corporate and operational strategy as previously communicated to the market. The strategy's objectives include the expansion of the Company's core range of products and market activation sales team over the next 24 months to meet growing consumer demand for craft brewed beverages and to take advantage of existing installed capacity.
